Payment processing FAQs

Q. How can I set up payment processing with Ruby?

- A. All it takes is a few steps:
 - 1. Contact Customer Happiness to provide your payment link.
 - 2. Your account will be assigned to a special queue that only rings to receptionists in a compliant facility.
 - 3. When a caller wishes to book an appointment or service that requires a payment, or requests to pay an invoice, the receptionists will ask for and enter the required information from your payment link.

Q. What are Ruby's payment link requirements?

- A. There are a few restrictions as to the payment links Ruby can support:
 - The payment link needs to work in a Chrome browser
 - Users can't be required to accept terms and conditions or create an account

Q. What is PCI compliance, and why does it matter?

A. Payment Card Industry (PCI) compliance is a set of stringent security standards designed to protect sensitive cardholder data. These standards include encryption of cardholder data, maintaining robust firewalls, updating antivirus software, and assigning unique IDs to individuals with computer access. While PCI compliance is not legally mandated, non-compliance can lead to significant fines imposed by card networks.

Q. How can I get a payment link?

A. Payment links are provided by payment service providers and payment processors, such as: Stripe, Square, PayPal, Helcim, Stax, Shopify, Payline Data, and others.
Once you've selected a provider, navigate to the "Pay by Link" option and create a shareable link. You'll provide this link to Customer Happiness to enable payment processing.
